LCRA Creekside Conservation Program

LCRA was created in 1934 as a Texas conservation and reclamation district. Now decades later, LCRA remains dedicated to land stewardship through the Creekside Conservation Program. This program began in 1990 to help landowners retain soil and enhance land productivity. It benefits the entire river basin by reducing sedimentation of streams, lakes and water supply reservoirs and lessening degradation of water quality and aquatic habitat.



Natural Resources Conservation Service

The USDA Natural Resources Conservation Service (NRCS) is the federal agency that works hand-in-hand with the American people to conserve natural resources on private lands. NRCS is a valuable land stewardship partner in Blanco County, providing the technical service necessary to implement soil and water conservation plans. NRCS brings 60 years of scientific and technical expertise to the Partnership.



Pedernales Soil and Water **Conservation District**

In the 1930's our country experienced some of the worst dust storms recorded in history. Protection of topsoil became a priority and as a result, soil and water conservation districts (SWCDs) were formed so landowners could work together at the local level to solve this major problem. The Pedernales Soil and Water Conservation District (PSWCD) is the cornerstone of land stewardship in Blanco County.




Federal 319 (h) Grant Augments the **Creekside Conservation Program**

In 2004, the LCRA Creekside Conservation Program was awarded a three-year, \$507,000 grant from the Texas State Soil and Water Conservation Board and the U.S. Environmental Protection Agency. In 2007, the TSSWCB approved another three-year grant totaling \$458,000. This funding enables more landowners to implement conservation practices
